PLYMOUTH MEETING, PA 19462
REORGANIZATION MEETING MINUTES, DECEMBER 1, 2014**

Board Secretary David M. Sherman convened the reorganization meeting of the Colonial Board of School Directors at 7:05 p.m. in the District Office General Meeting Room on December 1, 2014.

Mr. Sherman led the Pledge of Allegiance, read the roll, and announced that the purpose of the meeting was to elect School Board officers for the coming year and to authorize continuation of existing signature plates until new plates could be arranged.

Public Comments on the Agenda: None.

Election of Temporary Chairperson: Mr. Sherman sought nominations from Board members for the position of Temporary President. Mrs. Moore nominated Mr. Tabachnick as Temporary President of the Reorganization Meeting. Mrs. Suchsland moved and Mr. Brodsky seconded a motion to close the nominations. On a roll call vote, all voted in favor. The motion was carried, 9-0. Mr. Tabachnick was appointed as Temporary President and Mr. Sherman turned the meeting over to him.

Election of Officers: Mr. Tabachnick sought nominations for the position of Board President. Mr. Brodsky spoke to Mrs. Moore's leadership as Board President and noted the exciting initiatives taking place including the Plymouth Whitmarsh High School renovation and schedule changes at the high school and middle school. Mr. Brodsky nominated Mrs. Moore to a second term as President. Mr. Tabachnick moved and Mr. Brodsky seconded a motion to close the nominations and elect Mrs. Moore as President. On a roll call vote, all voted in favor. The motion was carried, 9-0. Mrs. Moore thanked the Board for the honor.

Mrs. Moore called for nominations for Vice President. Mr. Tabachnick nominated Mrs. Suchsland to a second term as Vice President. Mrs. Frangiosa moved and Mr. Brady seconded a motion to close the nominations and elect Mrs. Suchsland as Vice President. On a roll call vote, all voted in favor. The motion was carried, 9-0.

Mrs. Moore noted that with no change in officers there was no need to change the signature plates.

There being no other business before the Board, Mrs. Moore adjourned the meeting at 7:11 p.m.
